


Before first using your new CRES Pendant, it is most important that you read and follow these instructions, even if you feel you are quite familiar with this type of product. Keep this document handy for future reference.

THIS FITTING MUST BE INSTALLED BY A QUALIFIED ELECTRICIAN



- 1) Ensure the power is switched off at the mains.
- 2) Ensure the ceiling structure is capable to support the weight of the pendant.
- 3) Unpack the pendant carefully and place it on a flat surface
- 4) Loosen the screws (D) on both sides of the canopy (F) and remove the mounting bracket (A).
- 5) Drive the Rawl plugs (C) into the concrete ceiling, align the screw holes of the mounting bracket (A) with the rawl plugs and close to the ceiling, lock them with screws (B).
- Then connect the Live (L), Neutral (N) and Earth (E) according to the markings on the Terminal Block (E) :



- Adjust suspension cord length first by adjusting the suspension wire (G). Ensure that the screw in cord anchorage (H) is tight after adjustment.
- Fix the ceiling canopy (F) to the mounting bracket (A) by screws (D).
- 9) Pre-Installed GU10 globe (I).
- 10) Reconnect power at main switch.
- 11) Switch on the pendant.
