


LUCA Pendant Light 22747/05 matt white with white cord 22747/06 matt black with black cord


Before using your new Brilliant LUCA pendant, it is most important that you read and follow these instructions, even if you feel you are quite familiar with this type of product. Keep this document handy for future reference.

THIS FITTING MUST BE INSTALLED BY A QUALIFIED ELECTRICIAN



INSTALLATION INSTRUCTIONS

- 1) Ensure the power is switched off at the mains.
- 2) Ensure the ceiling structure is capable to support the weight of the pendant.
- 3) Unpack the pendant carefully and place it on a flat surface
- 4) Loosen the screws (D) on both sides of the canopy (F) and remove the mounting bracket (A).
- 5) Drive the Rawl plugs (C) into the concrete ceiling, align the screw holes of the mounting bracket (A) with the rawl plugs and close to the ceiling, lock them with screws (B).
- 6) Then connect the Live (**L**), Neutral (**N**) and Earth (**E**) according to the markings on the Terminal Block (E):



- Adjust suspension cord length first by adjusting the suspension wire (G). Ensure that the screw in cord anchorage (H) is tight after adjustment.
- Fix the ceiling canopy (F) to the mounting bracket (A) by screws (D).
- 10) Pre-Installed the GU10 globe (I).
- 11) Reconnect power at main switch.
- 12) Switch on the pendant.

In applications not intended for household, personal or domestic use, liability is limited to replacement or reimbursement of product only. Brilliant Lighting does not warranty the costs of removal or re-installation of this product or associated components.

Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if goods fail to be of acceptable quality and the failure does not amount to a major failure.
